Marina Anderson, Statewide Human Trafficking Training Specialist, FL Dept. of Children and Families

Since April 2020, Marina Anderson has been the featured speaker at 16 of STAC's Third Friday online webinars, locally produced programs reaching this community as well as the rest of the nation and world. Her expertise is vast and she shares her knowledge on topics ranging from sextortion and gangs to social media and working with underserved populations. Now a Statewide Human Trafficking Training Specialist at the Florida Department of Children and Families, Marina's training programs are among the most well-attended. In her prior role, she assisted STAC and others throughout the Panhandle with client needs and referrals. Marina is smart and caring. She infuses her educational programs with information about important trends, always making these events extremely interesting and compelling.

Capital City Youth Services (CCYS)

CCYS, the area's youth and runaway shelter, has supported and assisted survivors of human trafficking for many years. STAC has worked with CCYS to help shelter and provide services and support to youth and families impacted by sex and labor trafficking since STAC's inception. In 2024, CCYS welcomed STAC as a formal partner on a federal housing grant award which has brought a new and stronger focus on housing for trafficking survivors to this area. Since a large proportion of CCYS clients have been trafficked or are at severe risk of being trafficked, more youth and families are receiving a more comprehensive level of services and support than ever before. This collaboration and CCYS leadership will continue to benefit the youth and families of Florida's Big Bend for years to come.

Dr. Michelle Gayle, Deputy Superintendent, Leon County Schools

Dr. Michelle Gayle is a caring and involved leader. She was key to expanding the presence of human trafficking information and awareness throughout the school system in 2024. Dr. Gayle led by raising the importance of this issue in many ways, including inviting STAC to present at numerous Leon County Schools training programs and events with school social workers and administrators. This resulted in students who were in trafficking situations getting needed support. In 2025, Dr. Gayle continued to support trafficking survivors and help prevent sex and labor trafficking in the community by coordinating and organizing presentations to the Leon County School Board and to the community, including hosting a community-wide training event co-hosted by the Tallahassee Leon County Commission on the Status of Women and Girls, where she is a member and co-chair.

Legal Services of North Florida (LSNF)

Legal Services of North Florida has been a tremendous partner to STAC since its inception when STAC's offices were co-located with LSNF. Over the years, LSNF has represented many survivors of human trafficking working with STAC and other community organizations and advocates to provide immigration relief and support and collaborating on various initiatives and community events. They are always there to assist trafficking survivors and to partner with STAC on training programs, ensuring that LSNF attorneys and staff are trained to recognize human trafficking, and making sure these programs are accredited by the Florida Bar. LSNF is a strong and steadfast community partner, providing vital legal services and support to sex and labor trafficking survivors.

Leon County Government

Leon County has focused on ending human trafficking in this area for years, and has been a strong supporter of STAC as well, starting with funding its free business training program (STACPRO), adopting an anti-trafficking policy in procurement, sponsoring Imagine Freedom, and this year engaging STAC to train the entirety of Leon County staff on how to recognize and respond to human trafficking in all Leon County workplaces. In 2024, STAC worked with Leon County human resources to train more than 300 staff members and this training is now part of the Leon County learning management system. Special recognition goes to County Administrator Vince Long and human resources staff Anitra Thomas and Mary Barley for their hard work in making this training such a resounding success.

Renee Starrett

Renee Starrett retired in 2024 after working with STAC for seven years. Because of her efficiency and dedication, STAC could assist hundreds of survivors and provide training and education to thousands. Renee was instrumental in creating a strong foundation for STAC's operations and for taking the lead in many key areas too numerous to mention, including planning and organizing Imagine Freedom and training events. Renee worked tirelessly to create new ways for STAC to carry out programming, and her expertise and professionalism are unmatched. She also carried out the seemingly endless executive and administrative tasks with grace and good humor, always helping the agency to run smoothly and efficiently. Renee has been a STAC donor and volunteer, and her contributions have been great.
